### Artist Guidelines for: GFAA'S WINTER SHOW - JAN. 18 - MARCH 15, 2011

1. Exhibit Committee reserves the right to reject any work of art because of space limitations or subject matter.
2. Only artwork that can be hung on the existing hanging system will be accepted for display. Artwork must be framed with a wire hanger attached, ready to hang. Our hooks do not accommodate a saw-tooth hanger, unless a loop formed from wire is attached to the saw tooth. Fiber art and most other media including 3-dimensional pieces can be accommodated. Please call Sharon at 332-8059 to inquire about the requirements for preparing a sleeve and rod for fiber art such as quilts and **for any other questions about displaying unusual media. USE PAGE 3 TO LIST 3-D OBJECTS TO BE SHOWN IN OUR NEW 3-D OBJECT CASE.**
3. An application form should be completed for each artist, showing artist name, address, e-mail address, phone number, media used, title of piece, and price if for sale. In addition, space is provided on the application for a short bio for each artist. Viewers like to know as much about the artist as possible.
4. The application form includes a liability release (page 2 or on reverse) that must be signed, dated and brought with your artwork. Please **bring application, including page 2 and /or page 3/4 and the GFAA fee with your artwork.**
5. Please attach a label with your name and phone number on the back of your artwork.
6. All artwork must hang until pick up date and must not be removed until then. If an emergency arises, artist must contact the Exhibit Committee (372- 8673) and provide a replacement.
7. Information about how viewers can contact artists for purchase of artwork will be posted. This contact info will be located in a brochure which is posted in the literature racks near the elevators on each floor.
8. For this **GFAA** show, artwork must be delivered for hanging on **Tuesday, January 18 between 8 a.m. and noon.** (Second floor of Education Building) If you cannot bring your art at that time, please call a committee member below.
9. A reception for artists, their friends, family and Trinity congregation is scheduled following the 11:00 service on **Sunday January 23** in room # 211 2<sup>nd</sup> floor (12 noon to 1:00 p.m.). We invite you to be our guests at the 11 a.m. service.
10. Post cards announcing the reception will be available for pick up and mailing by all artists on January 18 when artwork is brought in.
11. **Please pick up your artwork on Tuesday, March 15 between 8 a.m. and 12:00 noon.** (You may have someone else pick up your art if necessary.) If a piece of artwork is sold while hanging, artwork should not be removed before end of show. No exceptions, please.
