1. Jurying will be arranged through GFAA and awards will be presented by GFAA. Information about the Judge will be forthcoming from GFAA.
2. Submit up to 3 art works : original 2 dimensional representational or abstract art pieces or photographs.
3. **Size : no larger than approximately 30" x 40" or total 70" that includes frame; weight: no more than 20 pounds.**
4. Mediums include acrylic, charcoal, collage, mixed media, oil, pastels, pen and ink, watercolor.
5. Art work must be framed or Gallery Wrap and prepared for hanging by wire – NO saw tooth hangers.
6. Water color should be under Plexiglas.
7. Subject matter should respect diverse views – no controversial political or religious subjects; any representations of the human body should be in good taste. No nudes.
8. **DUE DATE FOR SUBMITTING COMPLETED FORM WITH APPROPRIATE JPEGs, CD or PRINTS: Friday, September 9, 2011 – include name and title with images.** Send by either email to jane@paintingsbyjane.com or by regular mail to: Jane Polkowski, 2434 SW 50th Blvd, Gainesville, FL 32608.
9. **GFAA REQUIRES NONREFUNDABLE FEE TO COVER JURYING/JUDGING: GFAA members: \$25 for up to 3 pieces; non-GFAA members: \$65 up to 3 pieces.**

10. Artist will be notified by email by September 16 regarding accepted art work.
11. Accepted art pieces to be delivered to the 1st level Commons of Oak Hammock on October 10, 2011, between 10 AM – Noon. Please affix Artist name, title and phone on upper left hand corner of back of artwork. No prices should be listed.
12. Individuals interested in particular artwork will be directed to the artist for private transactions. There is no commission fee. If artwork has to be removed prior to end of show, it would be good if artist can provide a replacement with a comparable size art work.
13. Artist will provide 1 page Resume/Artist Statement - will be made available for viewing.
14. Artist will provide contact information that will be made available to interested individuals.
15. A signed copy of the Artist Application and Oak Hammock Waiver form will be required at time of art work delivery if not sent in earlier to Jane Polkowski to address in # 8 above.
16. A signed Release for inclusion of Artwork on website is required if artist would like to have their artwork displayed on The Art League at Oak Hammock website: www.galleryexhibit.info
17. **A free opening reception will be held on Sunday, November 6, 2011, 3-5 PM. Awards will be presented.** Friends and relatives of artists are invited to attend. Viewing by public other than during reception will be at designated days/times with one of the Gallery Docents by calling (352) 262-6719.
